



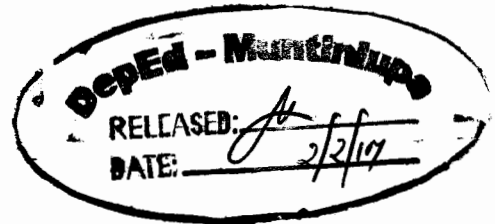

PRESCRIBING FEES FOR THE USAGE OF THE MUNTINLUPA SPORTS COMPLEX

WHEREAS, the Local Finance Committee, City Government of Muntinlupa, issued a Resolution recommending the fees to be charged for the usage of the Muntinlupa Sports Complex (MSC);

WHEREAS, said Resolution is meritorious as fairly based on those being charged by nearby sports complexes and actually verified by the City Engineering Office as to rate and cost of electric consumption;

NOW, THEREFORE, I, ATTY. JAIME R. FRESNEDI, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that the fees for the usage of the MSC shall be as follows:

| Area | Rate/hr with aircon | Rate/hr without aircon |
|--------------------|---------------------|------------------------|
| Center Court | Php8,500.00 | Php4,000.00 |
| Left or Right Wing | Php3,000.00 | Php2,000.00 |

This Executive Order shall take effect immediately.
