



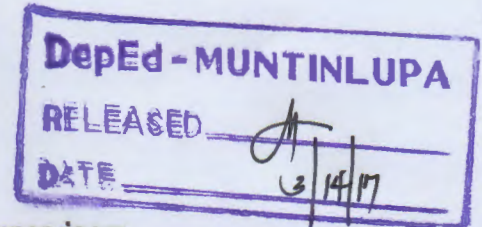



CHANGE IN DEPED MEMORANDUM NO. 226, S. 2016
(National Seminar on Department of Education Policies and Legal Process
of the Teachers' Dignity Coalition)

1. The National Seminar on Department of Education Policies and Legal Process of the Teachers' Dignity Coalition (TDC) was announced through DepEd Memorandum No. 226, s. 2016. However, Paragraph 4 of said Memorandum is hereby changed, to read as follows:
