



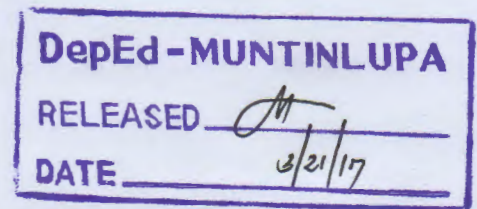

Immediate and wide dissemination of this Memorandum is desired.

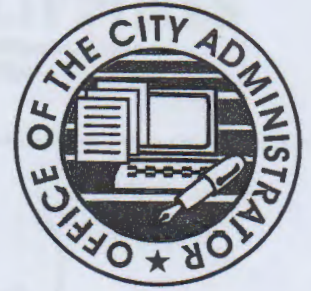

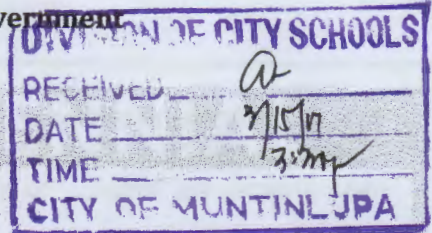



Specifically, the program is divided into two, and the respective links are provided below, hence:

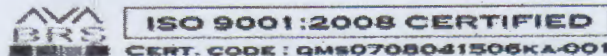
