



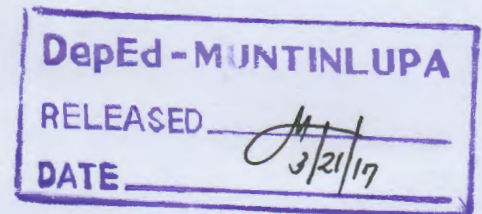

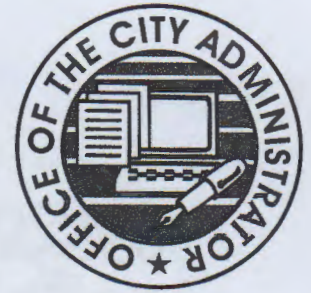

Subject : DILG Advisory on False Representations on Federalism

The Department of the Interior and Local Government (DILG) issued an Advisory dated 01 March 2017 warning all concerned that it has not authorized, on its behalf, any individual, group or entity to solicit in support of federalism, battle against illegal drugs, criminality, corruption and poverty.


Certain groups have represented themselves aligned with the government's campaign against the issues enumerated above, and some even carry identification cards with the DILG logo and collect fees.


Therefore, all concerned are enjoined to exercise caution; refuse assistance or support to these individuals, groups or entities; and report them, should they be encountered, to DILG Undersecretary Emily O. Padilla, who is in charge of DILG programs, projects and activities (PPAs) aligned with federalism, at telephone number 925-1130.

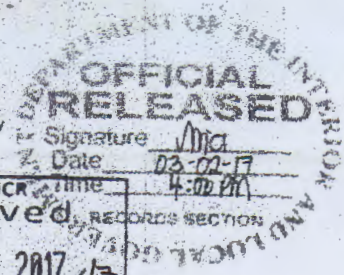

**SUBJECT: UNAUTHORIZED SOLICITATION FROM ORGANIZATIONS, ENTITIES
 AND GROUPS ALLEGING AFFILIATION WITH THE DILG**

This advisory is issued to inform that the Department of the Interior and Local Government does not authorize any organization or entity which solicits funds in support of federalism, among other government programs.

We have received reports that certain groups recruit members to support the call of President Rodrigo Roa Duterte for federalism and the battle against illegal drugs, criminality, corruption and poverty. While we find the group's objective laudable, we have noted that these groups issue ID cards bearing the DILG logo and fees are collected for the IDs. We wish to clarify that these groups are not in any way affiliated with or accredited by the DILG to conduct activities or events and to collect funds for federalism advocacy and other government programs. The DILG have not authorized these groups to collect fees for the IDs and funds for the conduct of their activities.

The Department strongly denounces the unauthorized use of the DILG seal, logo and letterhead and will not hesitate to take legal action against these groups.

All local officials are hereby ordered not to extend any assistance or support to these groups for their recruitment activities in LGUs.
